November Test Session: Coaches have requested a single panel test session in September. Melissa has checked with Roger and he is not available during suggested times. Melissa suggested a virtual test session for late September or early October. Carl will reach out to coaches regarding it while Melissa starts preparing for it. Discussion regarding our next in-person test session. Unfortunately dance partners were only available the weekend of November 10th or the following before December. November 10th is also a high school competition so we looked at the following weekend, however there is a Packer's home game so hotel accommodations are \$469/night. The decision was made to go with November 10th.

Melissa questioned if members are charged for not volunteering during test sessions. Holly said yes the fee is \$20. Melissa requested that it be adjusted to indicate a skaters test form would not be submitted if volunteering was not completed as required. Another suggestion was to raise the fee to \$50 for not volunteering. Doing this would require an amendment to the current handbook which has already been submitted to USFSA for the year. Carl will contact USFSA to see what the procedure is for properly updating a handbook mid-year.
